ELIGIBILITY: Open to 2008 members of the SCGA and WSCGA who are residents of South Carolina. Entries may be declined for those individuals who have not had reasonable activity on their club's handicap roster as of the most recent update.

ENTRIES: Entries must be filed either on attached form or **register online** at www.scgolf.org. Entries must be **received by 5:00 p.m. on September 24, 2008**. ****Field will be limited to 54 teams in each Division****. **Priorities are as follows:** (1) First half of the field on a first come basis from those teams that participated in the 2007 Championship – priority expires September 8th (2) Final half of the field will be decided on by each Association based on teams with the lowest combined handicap index. *Changes in partners after acceptance of entry and prior tournament history may result in loss of priority.* **Acceptance will be posted online at www.scgolf.org by noon September 25th.**

FORMAT: USGA rules apply. First round - Four Ball stroke play. Second round – Select Drive Alternate Shot. The field will be flighted after the first round. There will be a Senior Division for teams with **both** players being at least **55** years of age.

SCHEDULE: October 17th Practice Round - Call the Golf Shop to make arrangements at 843-815-8720. Cart Fee \$25 each.
Reception for Contestants 6:00 – 7:30. Guest will be at a cost of **\$20 and must accompany application**
October 18th First round – Four Ball Stroke Play. 8:30 a.m. and 1:00 p.m. double shotgun.
October 19th Final round and awards – Select Drive Alternate Shot. 8:30 a.m. and 1:00 p.m. double shotgun.

TEE TIMES: **Championship** Division will play at 1:00 on Saturday and at 8:30 on Sunday.
Senior Division will play at 8:30 on Saturday and at 1:00 on Sunday.
Pairings will be available October 1st from the SCGA Web Site: www.scgolf.org

CARTS: The use of golf carts is required. The *cost of carts for the tournament days and range balls* are included in the entry fee.

LODGING: The **Fairfield Inn Marriott** offers \$94 plus tax ph.#843-705-2300 – request SCGA rate. **Reservations should be made ASAP.**

REFUND POLICY: A full refund will be issued if the SCGA or WSCGA receives verified notification by September 25, 2008. A \$20.00 administration fee will be charged from September 26 – October 11. **No refunds after October 11th.**
