ELIGIBILITY: Open to 2008 members of the SCGA who are residents of South Carolina. Both players must be at least 18 years of age as of March 8, 2008. Entries may be declined for those individuals who have not had reasonable activity on their club's handicap roster as of the most recent update.

ENTRIES: Entries must be filed either on attached form or **register online** at www.scgolf.org. Entries must be **received by 5:00 p.m. on February 13, 2008**. Field will be limited to 56 teams. **Priorities are as follows:** (1) Exact teams that participated in 2007 (expires Jan 31). (2) Date of application received at SCGA office. **Acceptance will be posted on www.scgolf.org by Feb. 15.** *Please be aware that this event is a fundraiser for the SCJGA and all proceeds will be donated to the SC Junior Golf Association.*

FORMAT: USGA rules apply, 36-hole event: 18 hole Captain's Choice and 18 hole Four-Ball stroke play. The field will be flighted for Sunday's final round.

SCHEDULE: Feb. 22 – March 7 Practice Round - On a space available basis.
Make arrangements through Pro Shop (803) 788-3084.
March 8 First round – 18 hole Captain's Choice, qualify for flights. **Lunch following play.**
March 9 Final round – 18 hole Four-Ball Stroke Play by flights.

TEE TIMES: First round – **9:30 a.m. shotgun start**. Second round times will start on #1 & #10 at 8:00 a.m. Pairings available February 22 from the SCGA Web Site: www.scgolf.org

CARTS: Players are required to rent carts from Spring Valley Golf Shop for \$40.00 per player for the 2 days, range balls included.

LODGING: **The Courtyard by Marriott** is offering a special rate of \$94 per night + tax. Call 803-736-3600 ASAP and ask for the **South Carolina Golf Association Rate**.

REFUND POLICY: A full refund will be issued if the SCGA receives verified notification by February 13, 2008. A \$20.00 administration fee will be charged from February 14 – February 29. **No refunds after February 29.**
