ELIGIBILITY: Open to 2009 members of the SCGA who are residents of South Carolina. Both players must be at least 18 years of age as of September 19, 2009. Entries may be declined for those individuals who have not had reasonable activity on their club's handicap roster as of the most recent update.

ENTRIES: Entries must be filed either on attached form or **register online** at www.scgolf.org. Entries must be **received by 5:00 p.m. on August 26, 2009**. Field will be limited to 64 teams. **Priorities are as follows:** (1) Exact teams that competed in the Championship & First Flight of the 2008 event and whose application is received by August 17th. (2) Teams with the lowest combined handicap index. *Changes in partners after acceptance of entry and prior tournament history may result in loss of priority.* **Acceptance will be posted online at www.scgolf.org by noon August 28.** \$10.00 from each player's entry fee will be entered as a tax-deductible donation to the SC Junior Golf Foundation as approved by the SCGA Executive Board.

FORMAT: USGA rules apply, 36-hole four ball stroke play. Four flights with approximately 16 teams in each flight.

SCHEDULE: Upon notification of acceptance, each team will be entitled to **1 practice round**. Call the Golf Shop to make arrangements at 803-754-8109. Times available September 18th and earlier based on space available. **Reservations Required.**

September 19 First round. Tee times begin at 8:00 a.m. off of the #1 tee.
September 20 Final round and awards. Tee times begin at 8:00 a.m. off the #1 tee.

TEE TIMES: Tee times and pairings available September 2nd from the SCGA Web Site: www.scgolf.org

CARTS: Players are required to rent carts from Columbia Country Club for **\$20.00 per player per round of golf**, range balls included.

REFUND POLICY: A full refund will be issued if the SCGA receives verified notification by August 26, 2009. A \$20.00 administration fee will be charged from August 27 – September 11. **No refunds after September 11.** Accepted applications will not receive a \$5 registration fee refund.

RESTRICTIONS: Players are required to adhere to the dress code of the facility and conduct themselves in the manner of keeping with the highest standards of the SCGA. Players refusing to comply will be disqualified from the competition.
