ELIGIBILITY: Open to 2009 members of the SCGA who are residents of South Carolina. Both players must be at least 55 years of age as of March 24, 2009. Entries may be returned to those teams that have not had reasonable activity on their club's handicap roster as of the most recent update.

ENTRIES: Entries must be filed either on attached form or **register online** at www.scgolf.org. Entries must be **received by 5:00 p.m. on March 4, 2009**. Field will be limited to 64 teams. **Priorities are as follows:** (1) Exact teams that participated in 2008 event (expires Feb. 13). (2) Teams that did not participate in 2008 with lowest combined handicap indexes and earliest date of entry. *Changes in partners after acceptance of entry may result in loss of priority.* **Acceptance will be posted online at www.scgolf.org by March 5.** \$10.00 from each player's entry fee will be entered as a tax deductible donation to the SC Junior Golf Foundation as approved by the SCGA Executive Board.

FORMAT: USGA rules apply, 36-hole four ball stroke play. Awards will be for gross only, 36-hole total. Flights will be established based on first round scores.

SCHEDULE: March 6-23 ● **ONE** Practice Round - Space available basis - Make arrangements thru Golf Shop (803) 648-3333
 March 24 ● First round - Qualify for flights. **Lunch will be included the first day of the tournament.**
 March 25 ● Final round - 18 hole Four-Ball Stroke Play by flights.

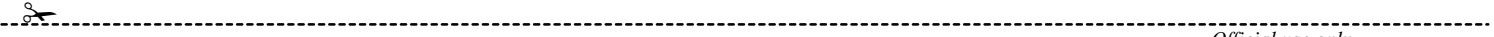
TEE TIMES: Tee times and pairings available March 10 from the SCGA Web Site: www.scgolf.org

CARTS: Players are required to rent carts from the Houndslake Country Club for \$40.00 per player for the two days, range balls included.

LODGING: Accommodations have been made available at Houndslake's 34 room lodge – the Guest House. Reservations can be made by calling 800-735-4587. Rates are available at \$95 per night.

REFUND POLICY: A full refund will be issued if the SCGA receives verified notification by March 4, 2009. A \$20.00 administration fee will be charged from March 5 – March 17. **No refunds after March 17.**

RESTRICTIONS: Players are required to adhere to the dress code of the facility and conduct themselves in the manner of keeping with the highest standards of the SCGA. Players refusing to comply will be disqualified from the competition.
Plastic, non-traditional spikes will be required for this event.
