**ELIGIBILITY:** Open to junior golfers who are residents of South Carolina between the ages of 13 and 17 as of June 14, 2011.  
**Also, the player or his parent/ guardian must be a member of an SCGA member club.**

**ENTRIES:** Entries must be filed either on attached form or register online at [www.scgolf.org](http://www.scgolf.org). Entries must be received by 5:00 p.m. on April 27, 2011. Exemptions are listed on the SCGA website. All other players will qualify at one of four qualifiers listed below. There will be **no qualifying** for the 13-14 bracket (age as of June 14) and the first 36 applications will be accepted.

**QUALIFIER:** On May 14, **The courses listed below** will host qualifying for the SCGA Junior Championship. Please list which site you prefer to qualify at below. Based on 40 players maximum at each site, all course assignments will be given on a first come first serve basis. You are not guaranteed your first choice. Pairings and course assignments will be made by May 6, 2011. Call the golf shops for practice rounds and local lodging information.

**FORMAT:** USGA rules apply, 54-hole stroke play with a 36 hole cut in two age brackets. Approximate field size is 140 players and will be divided into a 13-14 age bracket and a 15-17 age bracket playing the same set of tees.

**SCHEDULE:** June 13 Practice round.  
 June 14 First round.  
 June 15 Second round and 36 hole cut.  
 June 16 Final round and awards.

**TEE TIMES:** Tee times and pairings for first round will be posted at Oldfield and on [www.scgolf.org](http://www.scgolf.org) on June 8.

**CADDIES/CARTS:** Caddies are prohibited. Spectator carts will be permitted at qualifying sites and the championship proper and guided by SCGA Spectator Policies.

**LODGING:** Ask for the SCGA rate when calling: Fairfield Inn (Bluffton) \$89.00 and suites are available. Call 1-843-705-2300.

**REFUND POLICY:** A full refund will be given if SCGA receives verified notice by May 13, 2011. No refunds after May 13.

**SC/GA TEAM MATCHES:** The winner will receive an exemption to compete in the SCGA Amateur to be played at Colleton River. The top 8 finishers will qualify for the SC-GA Junior Team Matches to be played at May River Club on July 15-16, 2011.

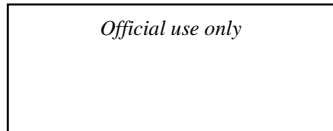
