### Eligibility

Open to 2026 male members of the SCGA who are residents of South Carolina. Both players must be at least 55 years of age as of March 2, 2026. Entries may be returned to those teams that have not had reasonable activity on their club's handicap roster.

### Entries

Entries must be **received by 5:00 p.m. on February 16<sup>th</sup>, 2026**. Field will be limited to 60 Teams. **Priorities are as follows:** (1) Teams with lowest combined handicap indexes as of January 16<sup>th</sup>, 2026, update. *Changes in partners after acceptance of entry may result in loss of priority.* **Acceptance will be posted online at [www.scgolf.org](http://www.scgolf.org) by February 20<sup>th</sup>.** All entries will be listed on a Pending List until approved by the SCGA based on the above criteria. The SCGA reserves the right to accept teams based on prior tournament accomplishments. Should the field not be at capacity (60 teams) after the original deadline, the SCGA reserves the right to take the first 60 teams to sign up before an extended deadline.

### Format

USGA rules apply 36-hole four ball stroke play. Awards will be for gross only, 36-hole total. Flights will be established based on first round scores.

### Schedule

- March 1      ***Designated Practice Round – Once field is set, make practice round accommodations through the Reserve Golf Shop. (\$60)***
- March 2      First round – Single Tee Start beginning at 8:00 A.M.  
**The field will NOT be flighted for the 2026 Championship**  
Lunch is available for players from 11:00 AM - 3:00 PM.
- March 3      Final round – Single Tee Start beginning at 8 A.M.  
  
Awards/Gift certificate ceremony after the round.
